## DEFINITION OF A SCRIMMAGE

A scrimmage is a practice that is a SIMULATED CONTEST. In scrimmages,

- both squads use the same field simultaneously with both coaches making corrections and giving instructions
- GAME RULES MUST BE ALTERED (SEE SPORT-SPECIFIC REQUIREMENTS NYSCHSAA Handbook)
- no official score is kept
- time(s) are defined in the Sport Standards section of the NYSCHSAA Handbook
- no admission is charged
- The use of officials would be permitted and encouraged whenever possible for instruction regarding the rules and proper application of rules. For lacrosse,

A lacrosse scrimmage must have modified time periods and include one or more of the following:

- Alternate possessions
- Start the scrimmage with either a draw (girls) or a face-off (boys)
- Include the following game situations:
  - Face-Off/Draws - Boys/Girls
  - Clears and Rides - Boys/Girls
  - Extra Man and Man-Down – Boys/Girls
  - Fast Breaks - Boys/Girls

## 2022 NFHS Boys Lacrosse Rule Changes

1-2-3: ART. 3 . . . .centered on goal and parallel to and 20 yards (25 yards on unified field) from the goal line...

Rationale: Update for dimensions of unified field layout

1-2-4: ART. 4... .. marked on each side of the field 20 yards (25 yards on unified field) from the goal line...

Rationale: Update to reflect dimensions of the unified field

1-9-1f: ART. 1f . . . A protective cup or pelvic protector is required for all players. Each player is personally responsible for wearing this protective equipment and the equipment shall not be modified from the manufactured state and shall be worn in the manner the manufacturer intended. Re-letter the remaining items.

Rationale: One of the core beliefs of the NFHS Rules is the minimization of the inherent risk of sports. A protective cup helps prevent blunt trauma injuries to the groin area that can cause serious damage, including severe bruising, internal bleeding, testicular fracture, or rupture. This can have serious, if not permanent damage to athletes. One of the biggest concerns for opponents to this rule is that officials cannot and should not check to see if a player is wearing a protective cup. As noted above, protective cups should be verified only through the coaches' certification process.

2-8-2e: ART. 2e . . . The timekeeper will sound the horn twice at the next dead ball when:

1. A player enters the field of play from the penalty area before being permitted by the rules.
2. The head coach requests a count of long

Rationale: These changes will eliminate responsibilities for the timekeeper and table keeper that put them in the role of game official. In nearly all cases the volunteer table crew is not trained in the responsibilities or duties like officials. The above duties should be the responsibility of a CBO if one is used or the game officials.

3-1-2: ART. 2 . . . After the first half, any time the score differential reaches 12 goals or more, starting with the whistle resuming play, the clock will only be stopped for a team time-out, official's time-out, or an injury time-out. All penalties that occur during a score differential situation will be running time. In this situation, running penalty time begins with the next whistle resuming play.

Rationale: Games that have a goal differential of 12 goals or more can run for more than two hours and with my high school programs having one main field or stadium it can result in timing issues with other sports or activities. During the second half, the winning team will often put in JV players so they gain high-level playing experience.

4-3-3 a, b, c, f, g: ART. 3 . . . The official conducting the faceoff will start the procedure by placing the ball on the midfield line at the spot on which the faceoff will take place.

- a. The official shall instruct the players to prepare for the faceoff by saying "down."
- b. Once the players are down, they are to move into their faceoff position as quickly as possible. Players shall stand as they get into position for the faceoff and must remain standing until the whistle sounds to start play.
- c. The crosses and gloves shall rest on the ground along the centerline, parallel to each other up to, but not touching, the center line. All fingers of both hands shall be gloved and wrapped around the crosse. The crosse head and the gloved hands shall be touching the ground. The hand closer to the throat shall be in a palm-up position.
- f. Once the players are in the proper position, ensure that the crosses are positioned such that the ball is in the middle of the head of each crosse.

g. Once the official is satisfied with the positioning of the players' crosses, he shall instruct the players to remain motionless by saying "Set.". For hearing impaired players, a reasonable accommodation for the "set" command and whistle sound will be provided.

Rationale: One of the changes made this past season for Covid modifications was for officials to place the ball on the ground first to indicate where the faceoff will occur. This rule has provided a visible marker for where players shall setup up for the faceoff. Players standing rather than kneeling compliments the changes in a, f, and g to play the ball first. Restricts face-off players from using the "moto-grip" to favor a standing neutral grip. Like the previous rule proposals, this will result in a fair and safer faceoff.

4-3-3i (NEW): ART. 3 . . . Upon the whistle starting play, each player must attempt to play the ball first before they may body check their opponent.

Other Rules Affected 5-3-3: ART. 3 . . . Body-checking of an opponent who has any part of their body other than their feet on the ground or while crouched for a faceoff.

Rationale: As a way to make the faceoff fair, safe, and result in fewer long stalemates this rule will ensure that faceoff players are playing the ball and not body checking or stick checking an opponent's body.

4-4-2: ART. 2 . . . When the whistle sounds to start play, the players in the wing areas shall be released but must avoid body-checking the faceoff players battling for control of the ball in the initial faceoff spot. All other players are confined to their areas until a player of either team has gained possession of the ball, the ball goes out of bounds, the ball crosses the defensive-area line, a whistle stops play for a time-serving foul, or whistle restarts play after a non-time-serving foul; when any of these events occur, the faceoff has ended. Players designated in the midfield area, and players designated within the defensive area may not interchange positions before possession has been called, and the faceoff has ended, but midfielders may substitute.

Rationale: Avoid checks to faceoff players that are in a potentially vulnerable position. This rule is already not well understood by players and coaches, and this change will codify what is not allowed and help protect players taking a faceoff.

4-5-3 NOTE: ART. 3 . . . Note: A ball in the air on a pass or a shot is a loose ball at all times, including after the horn sounds to end a period.

Rationale: This rule clarifies a ball that is not in possession is a loose ball.

4-9-2: ART. 2 . . . A goal shall be disallowed:

o. The ball is deflected or batted by the free hand or glove of an offensive player.

p. A goal will be allowed if the shot is released prior to the end of the period. Rule 4 Section 8

Other Rules Affected 6-6-2: ART. 2 . . . The following are examples of illegal procedure: a.

Touching the ball – A player shall not touch the ball with their free hand or glove his hands while it is in play. The exception is the goalkeeper while both he and the ball are inside the crease.

Rationale: The general principle is that the gloved hand is part of the stick in most cases – the exception being when determining if a player has crossed a line. This clarifies that any time a player's hand or glove is not on the stick and makes contact with the ball it is a technical foul.

Hence a deflection off a free hand or glove results in no goal. It also makes clear that if the ball

deflects off the hand/glove on the stick, the goal counts and that deflections off any other part of the offensive player will result in a good goal.

4-24-7: ART. 7 . . . Play shall be suspended immediately if any player, in a legal way, loses any mandatory equipment in the scrimmage area. If there is possession of the ball, the team in possession will maintain possession on the restart. If the ball is loose outside the crease, the ball will be awarded using the alternate-possession rule. If the ball is loose inside the crease, award the ball to the defensive team. If a player not in possession of the ball accidentally loses mandatory equipment and no other players are in the immediate vicinity, then the play may continue. If a player in possession of the ball loses mandatory equipment, play shall be suspended immediately, whether other players are in the immediate vicinity or not. A loss of equipment during the play of the game triggers an official's time-out and should not be confused with a player entering the game without some item(s) of mandatory equipment, which is a personal foul.

Rationale: This rule change removes some ambiguous language in the rulebook and clarifies how and when officials should stop play for equipment issues for non-goalies.

5-4-5: ART. 5 . . . A player shall not body check a player in a defenseless position. This includes but is not limited to: (a) body-checking a player from his "blind side;" (b) body checking a player who has his head down in an attempt to play a loose ball; and (c) body-checking a player whose head is turned away to receive a pass, even if that player turns toward the contact immediately before the body check; (d) body checking a player laying on the ground.

Rationale: Adds a prohibition on body checking while a player is on the ground in a defenseless position.

6-5-2x: ART. 2 . . . x. Failure to have and properly wear a tooth and mouth protector (unless it comes out during play).

Rationale: Clarifies the confusion around not having and having and not wearing a mouth protector. Also, updates the language here to be consistent with the language in Rule 1 Section 9 where a "tooth and mouth protector" not a mouthpiece is required equipment. Standard and consistent language makes searching an electronic version of the rules much easier.

#### 7-2 f and g: (NEW) PENALTY TIME

f. A maximum of three players from the same team can be in the penalty area, serving penalties at the same time. The penalty time of any additional player(s) waiting to serve is stacked and shall not start until the penalty time of one of the three players in the penalty area expires. The additional penalized player(s) shall wait in the bench area immediately next to the table area. A goal cannot release a player's penalty until he is in the penalty area and the time on his penalty has started to elapse.

g. In situations when multiple fouls occur during an extended slow-whistle situation, the following principles shall apply to administering the penalties:

1. Any player(s) already in the penalty box will remain there until their penalty is released.
2. If the sequence of fouls can be determined, the fouls will be administered and served in the order in which they occur, and non-releasable penalties will be served before releasable

penalties. If a player has multiple penalties, they will serve based on the sequence of the last foul.

3. If the sequence of fouls cannot be determined, the players with the most penalty time shall serve first, and non-releasable penalties will be served before releasable penalties.

Rationale: Introduces the term stacking to the penalties section and moves and important note into the rule section. Subjective language "severe" is also being removed in favor of objective language for the penalty order of operations.

7-8-2i: ART. 2 . . . The official shall withhold the whistle until:

i. A second defensive foul is committed, unless scoring play is in progress

Rationale: This rule change aims at clarification for when officials will delay blowing their whistle.

A scoring play is a longer duration event as opposed to a shot that is imminent.

## STANDARDS OF CONDUCT

1. All coaches must be aware that they are primarily responsible for controlling athletes during pre-game sessions, in locker rooms, on the playing field, on buses, or any other time they are representing their school. The conduct of athletes on and off the field is expected to be sportsmanlike. Actions such as taunting, jibes, vulgar language, and disrespectful attitudes are not acceptable at any time.

2. The conduct of coaches and school personnel on and off the field is expected to be sportsmanlike. Actions such as taunting, jibes, vulgar language, and disrespectful attitudes are unacceptable.

3. Wherever physically possible, all spectator areas are to be separated from player benches and the playing field. This could be as simple as roping off an area.

4. The shaking of hands is strongly encouraged at the end of every contest.

5. Any athlete who is expelled from a contest for unsportsmanlike conduct will be subject to NYSCHSAA penalty.

6. In the case of fighting, the player will be automatically expelled from the contest and will not be allowed to participate in the next scheduled contest, as well. This rule applies to playoff games and sectional games. In the event that the foul occurs in the last game of the season, the offending player or players will not play in the first game of his next sports season.

7. Officials and coaches shall notify the Athletic Director and section chairperson as soon as possible after the event.

8. It is expected that all coaches will take a responsible attitude in not intentionally running up scores.

9. The announcing of any home contest is expected to be unbiased. It is expected that all officials be skilled in the art of officiating and understand and enforce the league rule regarding unsportsmanlike conduct.

10. Penalties imposed by the league may be considered minimal, but they do not prevent schools from imposing their own penalties. Penalties may range from warnings to actions such as censure, removal from competition, or, in more severe cases, expulsion from league competition for the season.

\*NOTE: In lacrosse, any expulsion foul shall result in that player missing the next scheduled game.

## LEAGUE STRUCTURE

### League Play

Each participating team will play league opponents twice (home and away) during the regular season. Non-league games will count in regular overall season records. League records will be used to determine league standing.

### Officiating

#### Number of officials

- Two-man official system for all JV league games
- Three-man official system for all varsity league games
- Three-man official system for all playoff games

### ASSIGNMENT OF OFFICIALS

Officials shall be assigned via the MMHSAA Executive Director. Assigning agents shall distribute a complete list of assigned officials to all schools involved prior to the beginning of the season per the Arbiter.

## DETERMINATION OF A CHAMPION

### League standing and playoff seeding

In the event of a tie in the standings, both teams will be awarded the position. The following tie breakers will be used for seeding purposes only and include all league games:

- Tie Breakers
- Head to head
- wins over a common opponent in our league
  - o Tied teams start with the top of the regular season standings, and work their way down the standings until there is a difference in record against a team.
  - o Once there is a difference, the team with the better record becomes the higher seed.
- Goal differential between the teams that are tied
- If the above tie-breakers fail to break the tie, it will be broken by the flip of a coin by the league designee.
- In the event of a 3-way (or more) tie, the above procedure will be applied using only the games played between the tied teams
- Once a tie is broken by the above system, remaining tied teams will be broken by starting again at step 1.

### Playoffs

The playoffs will be bracketed. The 3 v 6 and 4 v 5 place teams will play a quarterfinal game. The home team must wear white jerseys and provide a score/timekeeper/trainer for the playoffs. The winner will advance to the state championship competition after the Monsignor Martin Playoffs.

### COMPLETION OF SCHEDULE

Each school in this association assisted in the development of the schedule and formally approved the final schedules; therefore, all schools must, unless there is some dire emergency, keep their commitments for the duration of the entire schedule or forfeit all remaining games.

### PLAQUES

MMHSAA shall supply plaques or trophies for the champion of the league as determined by the outcome of the league standings. Plaques will be presented to the winner of the MMHSAA championship game. There are no JV awards.

### REPORTING RESULTS

All coaches are required to report their scores and statistics in a manner that is approved by the league. Scores will be reported using the [MMHSAA Scores reporting form](#). Scores must be reported by the home team immediately following the game. All coaches must report their scores for non-league and tournament games regardless of location.

Athletic directors will be notified of delinquent statistical reporting. Failure to report scores and/or statistics will result in the following:

- First offense – warning to the athletic director and to the coach
- Second offense - \$100 fine and 24-hour notice to bring your stats up to date
- Third offense - \$250 fine and suspension of coach

We will also be using MaxPreps to track league records and statistics.

### ADDITIONAL INFORMATION

All home teams must provide a table at the center of the field. You must have an official timer (this is not to be done by referees). You must also have a horn to blow in the subs. If the home team cannot provide these things, the game will be forfeited.

### PLAYER MOVEMENT IN MMHSAA

Players may be moved between JV and varsity rosters until the following dates:

- Fall - third Friday in September
- Winter - January 1

- Spring - Friday, April 29, 2022

After the above dates, rosters are frozen. Any additions after this point will become permanent members of the varsity. It is recommended that each team submit a final varsity roster by each of these dates.

Following the varsity roster date listed above, a JV member may move up to varsity temporarily under the following circumstances:

- If a varsity squad has fewer than the designated number required for that sport due to reasons for ineligibility, illness, or injury, with the approval of the Executive Committee
  - Must be a different player for each occurrence
- The sport chairperson of each division and the team you are playing are notified prior to the players participating
- The JV player moves down when the original player comes back

Once the above dates have been passed, no varsity player may move down to JV.

NOTE: Seniors may not play on a JV team without permission of the Athletic Council for that division; the only exception is bowling.

## ROSTER SIZE

All rosters are unlimited in size for the MMHSAA. Please note: if your team qualifies for the CHSAA State or NYS Federation Tournament, their regulations may limit your roster size.

## SPORTSMANSHIP POLICY

### RESPONSIBILITY OF ATHLETIC DIRECTOR/COACH

The development of good sportsmanship depends largely on the goals and philosophy of the sports program and that of the school administration. Coaches are in a position to greatly influence the attitudes and values of the athletes. If the coach follows the rules of the sport and stresses fair play and honesty, the athletes are more likely to develop these values. It is essential that all coaches adhere to the Monsignor Martin Sportsmanship Policy.

1. Any coach excluded by a certified official from an inter school competition for unsportsmanlike conduct is ineligible to coach any inter school competition in that sport until after the next previously-scheduled contest at the same level (e.g., junior varsity, varsity, etc.) has been completed. The coach may not be present at the game site. NOTE: Not being physically present at the site means the disqualified coach is not to be present in the locker room, on the sidelines, or in the stands or site area before, during, or after the game/meet.

2. A coach who strikes, shoves, kicks, or makes other physical contact with the intent to do so to another person (e.g., official, another coach, player, or fan) shall be expelled immediately and banned from further participation in all sports for one year from the date of the offense.

## PLAYERS

Participation in athletics is an integral part of a student's educational experience. Such participation is a privilege that carries with it responsibilities to the school, league, team, student body, community, and student himself. In his play and in his conduct, he represents all these groups. Therefore, he has a responsibility to uphold the ideals of good manners and sportsmanship. His experiences while participating in athletics contribute to his knowledge, skill, and emotional patterns.

1. Any member of a squad ruled out of a contest for unsportsmanlike conduct or a flagrant foul shall not participate in that sport in the next previously-scheduled contest with a member school or in NYSCHSAA tournament play. Disqualifications from one season carry over to the next season of participation.

2. Any member of a squad who strikes, shoves, kicks, or makes other physical contact with the intent to do so to an official shall be expelled from the game immediately and banned from further participation in all sports for one year from the date of the offense. NOTE: Members of the squad include players, managers, scorekeepers, timers, and statisticians.

## OFFICIALS

Unprofessional conduct on the part of the official, including but not limited to, taunting, baiting, or use of profanity, shall be reported by a school administrator from the aggrieved school to the section executive director. A request will be made to the appropriate sport official's chapter to investigate the incident and to report their action to the section in a timely manner.

## VIOLATIONS

Unsportsmanlike conduct includes but is not limited to

1. Offensive language and/or gestures by the player, coach, or spectators
2. Intentional injury to another player
3. Flagrant misconduct, such as fighting
4. Destruction of another school's property by spray painting, egg tossing, or general trashing of the grounds. These infractions do not include "technical violations" related to a specific sport that result in disqualification.

## PENALTIES

Any one of the following penalties may be imposed against an offending player, coach, team, or school. The Penalty will depend on the severity of the infraction.

- LEVEL I - Reprimand and Probation
  - A letter will be sent from the grievance committee to the principal, athletic director, and coach (if applicable) and will include a description of the infraction.
  - A response from the offending school is to be sent to the grievance committee within three school days and must include the action that will be taken against the offender. With the written reprimand, a probationary status will be imposed on the team or individual for the remainder of the season. Probation does not limit eligibility for competition.
- LEVEL II - Suspension and Forfeiture
  - Forfeiture - will be imposed for team infractions. Forfeiture of a specific contest does not limit eligibility from further competition.
  - Suspension - involves an individual player or coach being suspended from competition for a minimum of one game. After the suspension has been served, the player or coach is eligible to return to competition.
- LEVEL III - Disqualification
  - Disqualification of a player or coach from competition is the final step taken after other options have been exhausted. The player or coach will be disqualified for the remainder of the season. Any person removed from a contest for unsportsmanlike reasons will be subject to a committee review of the incident.
  - If any school's team members are found guilty of destroying another school's property, that team will be disqualified for the remainder of the season, or, if after the season, will be disqualified from postseason play for the following school year. In addition, no player from the offending school will be eligible for league awards. If damage has been done to a school by non-athletes, a letter will be sent to the school involved with a request for a response within three days.

## NOTIFICATION

The coach of each team will notify their respective school's athletic director. The two athletic directors will then investigate the situation, discuss it with each other, and notify the Executive Director. The director will then take it to the sportsmanship committee, if necessary. The policy must be enforced whether it is a league or non-league contest.

## RIGHT TO APPEAL

A right to be heard must be claimed to the office of the Executive Director in writing within 24 hours of the incident (next working day). A school has a right to make an appeal of all decisions and this must be submitted to the Executive Director in writing within 24 hours of the decision being announced (next working day).

## SPECTATORS/PARENTS

Spectators and parents are guests at our athletic competitions; as such, they have a responsibility to abide by our school and league philosophy. Therefore, it is expected that good sportsmanship will prevail for the duration of the contest.

### SUMMARY

The Monsignor Martin High School Athletic Association believes that good sportsmanship is essential for all participating teams. The league encourages positive displays of sportsmanship and pledges to lead by example, in teaching and playing, in the hopes of shaping the future of our league.

## International Games

National Federation sanctions are necessary for international competition. Forms for requesting this sanction are available from the Executive Director of MMHSAA, and they must be filed 60 days prior to the event.

## Professional Tryouts

No tryouts for professional teams are approved except during the summer vacation. A student who participates in such a tryout is ineligible to represent the school.

## Athletic Events

### School's Responsibilities

1. Athletic Directors (or their designees) of participating schools are responsible for assigning adequate faculty supervision for all their students. The financial responsibility of these assignments lies with the participating schools.
2. Athletic Directors (or their designees) shall instruct their faculty supervisors and students that the following items are NOT ALLOWED at any game:
  - Sirens, noisemakers, whistles, megaphones, or any other distracting device
  - Confetti, streamers, etc

NOTE: THESE REGULATIONS WILL BE STRICTLY ENFORCED! Violators will be asked to leave, and the home school will be responsible for that person.

### Coach's Responsibilities

1. The coach is the official representative and leader of each team.
2. It is not his/her responsibility to demonstrate against officials or to intimidate them. This is a rule infraction in lacrosse, and, as the team leader, the coach should set a good example for spectators by acting with good sportsmanship at all times.
3. Recommendations for all coaches are listed below, and it is the intent of the Executive Committee that they be honored:
  - Dress - Each coach is encouraged to dress appropriately.
  - Appearance - Each coach shall be neat, clean, and well groomed.

- Speech - Each coach shall address everyone, including officials, with respect, courtesy, and understanding.
- Decisions - Coaches will not attempt to influence the decisions of officials.
- Acting - Each coach must be careful of his/her gestures and mannerisms so as not to incite the crowd.
- Sportsmanship - Coaches and players are requested to meet on the field directly after the game to exchange congratulations. This creates a good image.
- Supervision - The coaches must be on hand to supervise players.
- Valuables - Each coach is to make definite arrangements for care of team valuables during a contest. Valuables are not to be left unprotected.
- Postponement - Games will be postponed only if the participating school is officially closed due to weather or illness.

## MMHSAA Thunder and Lightning Policy

Thunder and lightning necessitates that all contests be suspended. The occurrence of thunder and/lightning is not subject to interpretation or discussion; thunder is thunder, and lightning is lightning. If lightning and/or thunder are observed, all outdoor activities will be suspended immediately. Players and spectators shall be directed to report to a shelter, a building normally occupied by the public, or, if a building is unavailable, participants should go inside a vehicle with a solid metal top (e.g., bus, van, car). The officials and responsible authorities shall make every reasonable effort to resume and complete the contest, with full consideration of the weather and site conditions (as they affect safety and playing conditions). The officials/coaches shall wait 30 minutes from the time the last boom is heard, and/or the last strike is seen before starting or resuming play.

### CLARIFICATION PRIOR TO CONTEST

If thunder/lightning is observed at the site of an outdoor contest by the officials/coaches 30 or fewer minutes prior to the scheduled start of that contest, the official/coaches and responsible school authorities shall not permit the contest to begin. Before the contest can begin, a 30-minute period void of any strike or boom must be observed.

### DURING THE CONTEST

If the officials observe thunder/lightning at the site of an outdoor contest during the playing of the contest, the officials/coaches shall immediately cease play for 30 minutes. Play may not resume until there has been a period of at least 30 minutes in which a boom or strike has not been observed. The rules of the sport shall determine whether the contest is "official" or must be resumed later.

## MMHSAA JEWELRY RULE

No jewelry, which includes visible body piercing objects, shall be worn in any sport. Any piece of jewelry that is visible at the start of or during a contest is in violation of the MMHSAA/NYSCHSAA Jewelry Rule. Religious medals must be taped to the body and under the uniform. Medical medals must be taped to the body, so they are visible.

## SPORTSMANSHIP

1. We believe that interscholastic athletics is an important part of education and supports the ideals and values embodied in good sportsmanship.
2. We believe that sportsmanlike behavior is essential if interscholastic competition is to contribute useful and constructively to the broad goals of education and to the quality of life of those involved.
3. We pledge ourselves individually and collectively to encourage and support the development and maintenance of a sportsmanlike atmosphere for athletic competition.

### Code of Conduct

1. A genuine interest in and enjoyment of interscholastic competition requires conduct that reflects the understanding that contests, as part of an overall school program, are intended to be enjoyed. Behavior that reflects a winning-at-all-costs attitude violates this standard.
2. Interscholastic competition provides valuable lessons and learning experiences that are not possible in the regular classroom setting. All involved must support the need to develop the ability to compete with enthusiasm and to accept winning with grace and losing with dignity.
3. Coaches, players, and fans should know that participation is an honor and privilege which requires them to conduct themselves in a manner that brings honor and pride to their school and community.
4. Respect for the cultural and ethnic diversity of one's opponents, their school, and community is a fundamental tenet of wholesome athletic competition. This standard suggests that planned activity is needed to demonstrate a warm and friendly welcome, mutual respect, and genuine readiness to participate in a sportsmanlike manner.
5. Players should demonstrate both knowledge of the rules and respect for game officials and their decisions. Coaches and school officials have the responsibility to teach and encourage these attributes.

### Sportsmanship Pledge

The New York State Catholic High School Athletic Association and the Monsignor Martin High School Athletic Association requires that game administrators, school administrations and officials enforce a ZERO TOLERANCE POLICY for athletes, coaches, and spectators. They will not tolerate negative statements or actions between opposing players, especially abusive language, trash talking, taunting, or baiting of opponents. If such comments are heard or actions seen, a penalty will be assessed immediately.

Spectators are reminded that "being in attendance today nor the fee paid to gain admission to this Monsignor Martin High School Athletic Association event does not entitle you to:

- a. berates officials;
- b. question the coach;
- c. make negative comments toward either team;
- d. display inappropriate behavior

The playing field is an extension of the classroom. Please practice good sportsmanship."

This announcement stands as the official warning of our ZERO TOLERANCE POLICY. Any violation of this policy will result in an ejection from the game. Let today's contest reflect mutual respect between all participants and spectators.

## TIMEKEEPERS

It is recommended that an adult be used as the timekeeper for all contests.

## SENIOR ALL-STAR AND OUTSIDE AGENCY CONTESTS

1. All Senior All-Star and Outside Agency contests MUST be approved by MMHSAA. In addition, Senior All-Star contests must be approved by the NYSCHSAA or the NYSPHSAA.
2. All Senior All-Star and Outside Agency contests must be conducted within the season dates approved by the MMHSAA or the Section VI Athletic Council for that sport. The calendar of approved seasons dates for all sports is posted on the section website\*.
3. Only seniors who have completed their secondary school eligibility in that sport may compete in these contests. A contestant may participate in any approved senior all-star athlete contest in the same spot during the school year. NOTE: A Senior All-Star contest by NYSCHSAA standards is one in which an athlete's participation is based solely on outstanding performance as a member of a high school team. If open tryouts are held, the contest is NOT a NYSCHSAA All-Star contest.

## MMHSAA AED Policy

Although the New York State legislature may have not gone so far as to make Education Law Section 917 applicable to nonpublic schools, the MMHSAA believes that its member schools should observe the law requirements as a "best practice" and therefore strongly encourages them to do so. For events that the MMHSAA hosts, schools will be asked to provide AED equipment as well as people who know how to operate the equipment. For competitions hosted by member schools, it will be the independent responsibility of each school to ensure whether and how the school will observe these best practices relating to AED's.

### All-Catholic Procedure

Coaches will be informed of the process. The All-Catholic selection process is confidential. All-Catholics selections are not to be announced prior to the announcement by the MMHSAA. Any school/coach releasing selections prior to the official announcement be fined \$100 per athlete announced.

# Heat Index Procedures

Administration of Heat Index Procedures:

- Feels Like Temperature (Heat index) will be checked one hour before the contest/practice
- by a certified athletic trainer, athletic director, or school designee when the air temperature
- is 80 degrees (Fahrenheit) or higher.
- Download the WeatherBug app to your phone or log into [www.weatherbug.com](http://www.weatherbug.com)
- Enter the zip code or city and state in the location section of the app or online.
- If the Feels Like temperature (heat index) is 90 degrees or above, the athletic trainer,
- athletic director, or school designee must re-check the Feels Like temperature (heat index) at halftime or midway point of the contest. If the Feels Like temperature (heat index) temperature is 96 degrees (Fahrenheit) or more, the contest will be suspended.
- **Please refer to the following chart to take the appropriate actions:**

## Wind Chill Procedures

### Administration of Wind Chill Procedures:

- Feels Like Temperature (Wind Chill) will be checked 1 hour before the contest/practice by a
- certified athletic trainer, athletic director, or school designee when the air temperature is 39 degrees (Fahrenheit) or lower.
- Download WeatherBug app to your phone or log into [www.weatherbug.com](http://www.weatherbug.com).
- Enter zip code or city and state in the location section of the app or online.
- If the Feels Like temperature (wind chill) is 10 degrees or below, the athletic trainer, athletic director, or schooldesignee must re-check the Feels Like (wind chill) at halftime or midway point of the contest. If the Feels Like (wind chill)temperature is -11 degrees (Fahrenheit) or lower, the contest will be suspended.
- Please refer to the following chart to take the appropriate actions:

	Feels Like Temp (windchill) above 40 degrees	Full activity. No restrictions
<b>RECOMMENDED</b>	Wind Chill Caution: Feels Like Temp (wind chill) 3 degrees to 20 degrees	Stay adequately hydrated. Notify coaches of the threat of cold-related illnesses. Have students and coaches dress in layers of clothing.
	Wind Chill Watch: Feels Like Temp (wind chill) 1 degrees to 10 degrees	Stay adequately hydrated. Notify coaches of the threat of cold-related illnesses. Have students and coaches dress in layers of clothing. Cover the head and neck to prevent heatloss.
	Wind Chill Warning: Feels Like Temp (wind chill) 9 degrees to 10 degrees	Stay adequately hydrated. Notify coaches of the threat of cold-related illnesses. Have students and coaches dress in layers of clothing. Cover the head and neck to prevent heat loss. Consider postponing practice to a time when the Feels Like temp is much higher. Consider reducing the amount of time for an outdoor practice session.
<b>REQUIRED</b>	Wind Chill Alert: Feels Like Temp (wind chill) -11degrees or lower	No outside activity, practice or contest, should be held. Approved May 1,2010; Updated July 27, 2017

**Note: Alpine Skiing will be exempt from this policy and will follow the regulations of the host ski center where the practice or event is being held.**
